



Registered companies in "Building Rehabilitation Company Database"

Type of Registration: Authorized Persons (Consultancy firms providing services of Authorized Persons)

Registration Process:

A company successfully registered under "Building Rehabilitation Company Registration Scheme" is required to provide "Basic Company Information" and complete "Assessment for Core Requirements".

1. Basic Company Information: to be provided by the registered company, including name, address, professional qualifications and the number of professionals, and past violations, convictions and records of disciplinary action, etc. The completeness of the information will be assessed through an off-site review.
2. Assessment for Core Requirements: The Hong Kong Quality Assurance Agency will randomly sample a completed project to assess whether the company has the related mechanisms or systems in quality management, professional service and customer service ("project management mechanism and system") for performing building rehabilitation works. The assessment will only cover the existence of the mechanisms or systems but not the quality of the mechanism or system itself. For details of the assessment, please refer to the Scheme Handbook.
3. Validity period of registration: a successfully registered company will receive a registration certificate valid for three years, and the company must continue to implement its own project management mechanism and system within the validity period of registration. When the validity period of the registration expires, the company needs to re-apply for registration.
4. Validity period of the information: a successfully registered company is required to update the company's information regularly. The date of the latest updated information will also be displayed on the website for public reference.
